Minutes of the Meeting:

1. Welcome and Opening Remarks:

The Chairperson, Dr. (Prof.) Pratima Shukla, welcomed all members and expressed satisfaction with the progress made since the first meeting. She emphasized the need for continued collaboration to meet institutional goals.
